All charges are inclusive of VAT with exception of paragraph A (i) and A (ii) which are exempt from VAT

Brightlingsea Harbour Commissioners by virtue of powers conferred upon them by Section 26 of the Harbour Act 1964, now incorporated in the Transport Act 1981, have determined that the following charges shall be levied upon ships and goods and all private pleasure vessels and craft entering, using and leaving the Harbour. Services are provided in accordance with our Terms and Conditions of Business unless otherwise agreed in writing.

The charge for maintenance posts (Commercial) and laying on the Town Hard (Commercial) is for any vessel owned or being worked on by a commercial entity. Commercially registered fishing vessels are exempt charges for laying on the Town Hard in accordance with original deed of gift. The Commercial Activity Agreement will enable a commercial entity to lay vessels on the hard and use the maintenance posts as required for the year.

BHC manage the Town Hard, Boat Park and Town Jetty which are owned by Brightlingsea Town Council. The owner of each vessel launching over the Hard must complete a registration form and display a sticker indicating compliance. Day launch and multiple launch tickets (valid from 1.4.15 - 31.3.16) are available, enquiries regarding launching fees and registration should be made at the Harbour Office or Hard Masters Hut.

All administrative matters are dealt with at the Harbour Office. Launching fee is per boat. Harbour dues, with the exception of where incorporated with launching fees, are only charged once for each household. Daily launching fees cover launching within a 24 hour period.

Vessels including their tenders that hold a BHC mooring agreement are exempt from launch fees. No exemption of launch fees for vessels on any other mooring.
