#### 4098 **USAR Update**

The HM confirmed that the project will finish in March 2020.

#### 4099 **Byelaws/PMSC**

There was a discussion regarding safety in the Harbour with the increased numbers of Harbour users. F Brown believed that many of the byelaws were exempted by the implicit 'Customs and Practice' contained within Byelaw 41. I Finch thought this was not satisfactory and should be subject to risk assessment. The Commissioners accepted that as duty holders they have a responsibility to ensure that the Byelaws are fit for purpose and upheld. It was decided that there should be a public consultation. The HM would publish a date and find a suitable neutral location to hold this event.

#### 4100 **January Meeting**

It was agreed by Commissioners that there would be no January meeting on New Year's day, as it was likely there would be several potential Commissioners' gatherings scheduled for January 2020.

#### 4092 **Matters raised by Members**

D Nicholson asked if the Harbour would agree to allow for a CCTV camera to be attached to the leading light post next to BSC, the HM invited him to come to the office to discuss.

F Brown informed Commissioners that BSC would be hosting an Optimist Championship in March 2020.

I Finch wished to pass on the fact that at an engagement with TDC, they were extremely complimentary about the Harbour. They specifically referred to the DHM as the member of staff who had been particularly helpful.

I Finch also reinforced a comment made at the last meeting that Countryfile had expressed a desire to doing something involving the Harbour in 2020, the HM suggested he invite them to a meeting which is happening on 12<sup>th</sup> December 2019 regarding the USAR project.
