# **South Coast Visit**

The HM gave a summary of his visit to the Various Harbours and clubs on the south coast. A great deal of best practice was presented and observed, many shared common problems and found resolutions.

## 4106 The Budget

The HM published the draft Budget for FY 20/21 following a comparison of the current year. The HM stated that he would send out the budget to commissioners for consideration.

### 4107 USAR

BHC won an international industry award which was collected in Holland on 30<sup>th</sup> January, it was for the reuse of sediment. Earlier at a meeting in Rotterdam, BHC was allocated further funding, since other partners had failed to spend elements of their original allocations. The project closes in April so BHC will use the money and the time to dredge part of the Marina and South Channel and use sediment from the latter to fill more of the borrow pits.

### 4108 BTC

The Chairman and HM had a meeting with the members of the Town Council. There was a general acceptance of the detail of the proposed Licence. The Council wished to attach an addendum with a number of other responsibilities and directions. Once the HM was in receipt of it, the document would be sent to Commissioners for review. The aim would then be for the Commissioners to meet with the Council for signature during March 2020.

# 4109 Commissioner Reappointments

A Scott and F Brown were reappointed for a second term as Commissioners.

### 4110 Matters raised by Members

F Brown sought information on the new rules governing the transporting by trailer of BODs. The Chairman stated that following an incident which ultimately involved police, he had directed the HM to collaborate with the Police and find a workable practice that would enable mooring holders to get their craft out into the creek for the new season. The final version of that code of practice has yet to be endorsed by the police, once that happens it will be promulgated.

A Scott gave an update on the Solar Pontoon. Expressions of interest were being sought. Once these had been reviewed, tender documents would be produced. HM confirmed that fraud mitigation strategies had been employed in answer to a point raised by A Scott.

N Taylor considered that the Harbour was communicating better with its stakeholders, but asked that, in future, consideration is given to separating any Christmas message from information about the renewal of moorings.
