PPE

Everyone should have on their person a face covering, although it won't be required at all times the option will always be available to you. All Harbour facilities will have antibac spray or hand washing facilities.

Visiting Yachts

Will be able to use the new Shower and toilet facilities, Water Taxi and head into the town to use pubs and restaurants. If intending to arrive beyond Taxi hours please telephone the office in advance. The office is open Sat/Sun, 9-5.

Visitors entering from countries outside of the UK (not included within a bridging arrangement) will need to fill in a Public Health Passenger Locator Form, this can be done electronically.

Taxi

From July 3rd we will extend the timings once more to our usual schedule.

Ferry

Each passenger will book onto the ferry in advance by calling the office on or in person and be allocated a seat. Joiners at Point clear or East Mersea must book, that can even be done whilst queuing (socially distanced) at the pick-up point. The cox will wear PPE, Gloves and face covering when within 1 meter of anyone's face. Passengers should have face coverings available. The modified ferry has protective partitions between groups of passengers which will only be used in bubbles, therefore can travel 6 independents or up to 12 in bubble combinations. On entering the ferry passengers will have their hands sprayed with an antibac fluid then be directed to their allocated seats, first on one side then on the other, passengers will alight using the same managed process. We would ask that passengers queue responsibly, at Brightlingsea they should wait by the Bus shelter to be taken down the jetty to the Ferry. Office will be manned Sat and Sun.

Showers and Toilets

Although they are naturally separated for enhanced virus protection when out in the open areas customers will need to exercise caution, signs are up to remind them. Cleaning of the facilities will happen regularly.

River Cruises

Later in the month as other establishments open we will reinstate the cruises. Similar alterations will be made to the vessel to ensure a Covid secure environment.

Marina

The recently dredged marina still has some berths left, with WiFi (Fibre in very near future), Electricity, Water, new showers and toilets, new easy read depth gauge. If you need somewhere to berth give us a call.

Crabbing

Unfortunately Crabbing cannot be made Covid secure on our Jetty this year, however there are a number of alternatives; the boating lake, the Prom at higher waters and near the paddling pool. To get there from the harbour is a short walk through the marina complex and onto the prom.

4126 Matters raised by Members

PH was keen to liaise with the town to prepare for the re-opening on the 4th offering to advocate on behalf of the Harbour. The HM welcomed her involvement. **DN** asked if the Commissioners could discuss the ferry

landing costings at the next meeting. Chairman stated that it would appear on the agenda. IF was keen to discuss environmental issues at the next meeting particularly energy saving and asked if that might appear on the Agenda. It has a great deal of relevance to the Harbour and would benefit from more time for all views to be shared.
