- **5074** Budget FY21/22 The HM presented the Budget and answered questions that had been sent to him in advance. The Commissioners then agreed the FY21/22 Budget
- 5075 Harbour Normalisation Process The HM displayed the current pictorial guidance generated by the Harbour as published on the Website and social mediaand explained it to members. He was clear that if government advice changed then so would this guidance.. It was his view that if public meetings were to take place once more that would be in late May. FB stated the Brightlingsea Sailing Club (BSC) would start active sailing on 30th March. The Chairman concluded the next commissioners' meeting would take place on Wednesday 7th April at 1000hrs via webex, with a view to return to normal evening meetings in May.
- 5076 Commissioner Working Groups The Chairman expressed his desire to reinstate commissioner working groups, to cover, for example, the ferry landing stage development, the posts for St Osyth pontoon, Waterside Proposals and the River/River patrols in concert with CBC and TDC. This would be in addition to the solar pontoon group. Composition of such groups would be discussed at the next meeting.
- Matters raised by Members FB stated that the Regatta will be taking place on 1011 July the scale of the event would be decided at the AGM on 13th March. NT
 asked for an update on the dredging the HM responded that the Fuel berth and
 the channel opposite the wharf had been completed and the pontoons were
 currently being worked on. The focus would then be on the area forward of the
 hammerhead and the entrance channel. Maintenance dredging of the marina,
 using BHC's dredger, continues. IF stated he was keen to get to the harbour
 office to continue the survey of the effect of the use of Hard posts started before

the recent Coronavirus lockdown.
