5161 The Budget

The current year's budget was compared against the actual figures, revenue had increased more than anticipated which ultimately resulted in achieving a small gross profit.

The Budget for 2022 – 23 was then presented by **HM**, this would be circulated to the Commissioners shortly and will include a cash flow forecast.

The **HM** highlighted the extraordinary spending over the next few months and confirmed that despite that we have sufficient cash to continue operations as normal.

Commissioners would consider the 2022-23 budget for approval at the next meeting.

5162 The Ferry Landing

The **HM** updated the Commissioners on financial implications of constructing a new Ferry landing.

5163 Chairman Succession

Andrew Scott was selected by Commissioners to succeed the current incumbent; this would happen following the August meeting. In addition, **NT** and **IF** would also be leaving. Three more Commissioners would need to be recruited prior to the September meeting, so they might sit in and observe before taking up their appointments in October. The selection criteria would be discussed by Commissioners at a later meeting.
