5221 BTC Agreement

The retiring **Chairman** described the situation regarding the draft licence to operate the Jetty, Boat park and hard. There was a discussion by members which concluded that the Chairman would write to the town council.

5222 Visitors

There had been a noticeable increase in the number of visiting yachts over the last few years, exclusive of Covid year. Data was displayed.

The Commissioners agreed that they will need to consider the strategic implications of this visitor growth, as at some point the harbour may potentially be overwhelmed. Discussions took place but no definitive outcomes were uncovered. Commissioners would continue to follow the data to decide next steps.

5223 Matters Raised by Members

NT referred to an anecdote regarding a German yachtsman that regularly visited Brightlingsea and stated that it was the best little harbour in Europe because of its friendliness and helpfulness. It was his closing statement following his eight year tenure as Commissioner.

IF stated his three years as a Commissioner had been a privilege.

JA formally stood down following twelve years as Commissioner and Chairman, he wished the harbour well for the future. He asked the Commissioners to continue being guided by the BHC aim of preserving the unique character of the harbour.

HM thanked the outgoing Commissioners for their service. He then asked that new incumbents get in touch to arrange a day at the harbour where they might immerse themselves in the operation to gain insight into the day to day functioning of the harbour.
