Designated Person (DP) visit Feb 20/21<sup>st</sup> he will conduct an inspection, as required by the PMSC, during his visit. DP reports direct to Commissioners rather than HM. Colin Watkins acts as the Commissioner contact.

Solar lighting replacements fitted to pontoons.

Workboat code edition 3,required the procurement of a MOB practice Dummy, PLB, and an additional VHF radio. HM stated that Colne Leader is now compliant with the code.

Trinity House regularly inspect BHC aids to navigation and associated office paperwork / systems. It covers the aids we are responsible for as the local lighthouse authority. Recent inspection resulted in an excellent report.

Wreck Buoys deployment pack has been prepared. Buoys are held in the BHC yard.

HM met with St Osyth Parish Council to discuss PWC management and launching from Point Clear. He provided a short update. The police, BTC, Essex CC and Bourne leisure also attended the meeting. The HM expects to have further meetings with ST Osyth PC on this topic later this month and next.

PMSC Response to British Ports Association (BPA). ,**HM** sent BPA feedback on PMSC draft issued for consultation by the Dept of Transport, **DS** stated that he had spoken with the Chief Executive of BPA at a Dinner last week who stated he had been very grateful for the Harbour's feedback.
