### **Budget Increase**

### **Bathymetry**

• Spit has moved 15m in last 7 years; curving east

- · Neck of the spit is eroding
- Creek entrance has depths of 0.6 m. compared to 1m target.
- · Oyster beds appear stable
- It would be helpful if the annual drone survey was undertaken at, roughly, the same height of tide each year. This would aid Commissioner understanding of any changes. Action HM

 It would also be useful if a drone survey could take place around low water, again the aid Commissioner understanding, Action HM НМ

#### **Local Government Reorganisation**

 Commissioners need to keep watching the brief and maintain contact with our CCC and Tendring contacts.

### Strategic issues that Commissioners believe need to be considered.

- Increased severe weather though we currently seem to be seeing fewer storms during the season
- Increased flood risk, possibly combined with impact of weather induced tidal surge
- Movement of the spit
- Silting across the harbour; ensuring our dredging approach remains appropriate
- Change on boating user profile, activity and types over next 10 years.
- Managing end of life vessels
- Fall off in demand for drying / part tide berths and increased demand for pontoon / marina berths.
- Consideration on types and number of moorings offered.
- BTC waterfront development: BHC involvement
- The future of commercial entities in the harbour.
- Future charging facilities for electric boats
- Gunfleet sands windfarm; evolving support requirements.
- Review of ATON placement.
- Colchester City Council strategy for, and management of, the Hythe and River Colne

#### Other items

10 years of BHC: Formed 1927

### Key strategic issue for BHC focus

- 1. Study to understand the feasibility (and costs) of increasing pontoon berths, making use of lower demand drying / part tide berths
- 2. Continue work on understanding movement of the spit and how to may impact the harbour.
- 3. Continue with dredging. Consider if a different approach is needed to meet our depth aspirations.
- 4. Small team to review harbour entry and exit pilotage and navigation aid needs for both large and leisure vessel, given the movement of the spit and leisure user issues and provide recommendations.
- 5. Engage with **BTC** on their waterfront development plans and decide how **BHC** might be involved in both their creation and future delivery.
- 6. Continue to monitor changes in boating user profile and their requirements and consider how **BHC** may need to adapt.
- 7. Support **HM** in his approach to managing end of life vessels
- 8. Continue current level of support for **CCC** in their Hythe and River Colne activities. Encourage **CCC** to develop a strategy for these

	areas, then see if <b>BHC</b> can play a part in helping deliver that strategy.
