The HM stated he would, for future reports, emphasise the requirements for reserves and how they will be spent long term.

Weather generally OK throughout the summer. Afternoon tea take up has been successful. Rowhedge Pub run has proved popular. Harbour Tours are also popular. Land and water harbour tour in partnership with museum popular. **Colchester City Council CCC** Hythe Clearance 5 x boats and some rubbish clearing is required: there seems to be a determined effort by CCC to improve the situation. Haven Road project – Improvements due to new valve and jetting out drains, some will be redirected. Stage two on the Bank repairs are nearing licence approval by the MMO.

5484	PWC River Patrol This season there has been a noticeable improvement in behaviour of PWCs. Some powerboats have demonstrated poor compliance as have some foiling vessels. Vessels entering the harbour at Point Clear are being registered, HDs and details taken. This helps improve accountability from those launching from Point Clear. Reduced anonymity of users resulted in better behaviour and safer waters.	
5486	Matters Raised by Members TP questioned whether speed limits might be applied differently. How to balance tolerance and the rules enforcement. Commissioner views were mixed. There was a suggestion that safe lanes might be created. HM thought a discussion on this topic would be appropriate for one of BHC's regular meetings with clubs. HM invited TP to work with him on the future club meetings.	НМ, ТР
	RD wished to express his admiration for the staff employed by the harbour during the summer, he cited many examples of staff going above and beyond to meet yachtsman requirements. He had spent many hours listening to his VHF to the ways teams had handled customers. The Chairman also cited an example of the Duty HM on overhearing that a customer was unable to start their engine due to a flat battery, brought one out to get the engine started.
