Water Quality Sampling Activity by APEM Group

Introduction

Mariners are advised that APEM will be conducting water sampling and sediment grabs activities over a 12-month period starting in October 2025 in The Blackwater Outer, Crouch and Colne. These operations will support environmental monitoring and research efforts. Further details, including specific locations, timings, and safety guidance, are provided below.

Research details

Vessel JEAN T with length 16.89m and breadth 5.25m, and GNH Crusader with length 14.8m and breadth 4.9m will display the appropriate signals/lights as appropriate for their vessel is able to maintain a continuous listen watch on VHF Channel 11 and 16. There are no requirements for an “ease down” from other crafts.

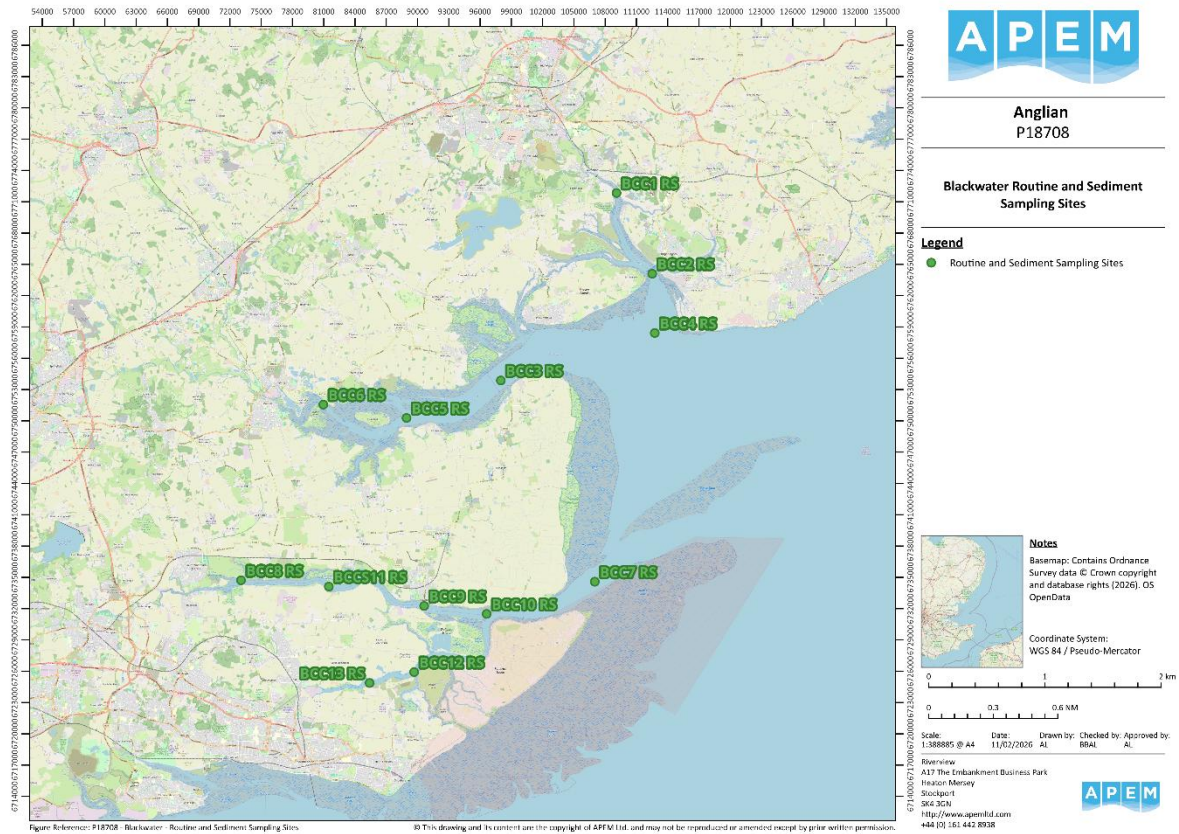
